The DSAWM is pleased to provide information to all its customers about its online privacy policy. Please be assured that the DSAWM uses its best efforts to protect the privacy of visitors to this web site.

Types of Information We Collect and How It Is Used

DSAWM only gathers personal information, such as, first and last names, home addresses, email addresses and credit card numbers, when voluntarily submitted by you. If you make an online donation, personal information will be collected from you in order to process that donation. With your permission, we will use personal information collected from you to send you information, such as, DSAWM updates, newsletters, special event invitations, and fund-raising campaigns. If you do not elect to receive such materials, we will not send them to you.

Sharing of Personal Information

Companies may be engaged by DSAWM to perform a variety of functions, such as, assisting with donation collection, providing technical services for our web sites, etc. These companies may have access to personal information if needed to perform such functions. However, these companies may only use such personal information for the purpose of performing that function and may not use it for any other purpose. Other than as provided in this privacy policy, the DSAWM does not sell, transfer or disclose personal information to third parties. The DSAWM reserves the right to use or disclose any information as needed to satisfy any law, regulation or legal request, to protect the integrity of the site, to fulfill your requests, or to cooperate in any law enforcement investigation or an investigation on a matter of public safety.

Cookies
